

**Turnstone Corvette Raffle Rules:**

1. Tickets may be purchased via cash, checks or debit card. Credit card purchases are not permitted under Indiana Charity Gaming Laws.
2. Entrants must be 18 years of age or older.
3. The winner will be asked to sign an affidavit that he/she complies with the minimum age requirements and that the winner purchased the winning ticket via an approved purchase method.
4. Entrants to this raffle do so of their own initiative and are responsible for compliance with the entrants own state and local laws.
5. Winner need not be present at the time of the drawing to win.
6. This raffle is a fundraising effort of Turnstone Center for Children and Adults with Disabilities, Inc., a 501(c)3 not-for-profit social service agency located in Fort Wayne, Indiana and is being conducted under the laws of the State of Indiana. All proceeds will support programs at Turnstone.
7. Due to postal regulations, raffle ticket stubs cannot be returned by mail if purchased through the mail or over the phone. When the order is placed, Turnstone will complete the ticket with the information provided by entrant and the ticket will be placed in the raffle drawing at Turnstone. Purchasers can email [Tana@turnstone.org](mailto:Tana@turnstone.org) or call Turnstone to check when the order was processed and to obtain their ticket numbers, if so desired.
8. The winner is responsible for all local, state and federal taxes, as well as transfer and license fees and costs as well as any costs of insurance, transportation and storage of the automobile following the date of the drawing. The winner understands, acknowledges, and agrees that the winner is receiving a prize and will hereby release and discharge Turnstone, and any additional sponsors, their employees, agents, officers, directors and legal representatives and assigns from any and all claims, liabilities, damages, losses or expenses arising from or caused by the award of such prize, including, but not limited to the payment of any and all taxes that are due.
9. Turnstone makes no representation as to the condition of the vehicle, nor does it make any warranties, or fitness for a particular purpose, originality, mileage, condition or compliance with safety or emissions laws or regulations. By purchasing a raffle ticket, participant acknowledges that the winner will accept the vehicle, "AS IS", "WHERE IS."
10. In the event the corvette is lost, damaged, stolen, destroyed or otherwise not available prior to the raffle drawing, Turnstone's liability to a participant shall be limited to the refund of ticket price to such participant.
11. The winner has the irrevocable option, to be exercised at the time he or she first claims the prize, of receiving a \$15,000 cash payout instead of taking ownership of the Corvette. If the winner chooses the cash option they will be responsible for all local, state and federal taxes, including without limitation, all required withholding taxes.
12. Ticket purchases are not tax deductible.
13. The winner will be announced at the official drawing to be held on October 12, 2017.
14. If the winner is not present he/she will be notified via phone, certified mail or email within 7 days of the drawing. The prize must be claimed within 30 days of the drawing. If the winner declines to take the prize or the prize goes unclaimed, Turnstone will immediately notify the runner up that he/she is the winner of the vehicle.
15. To claim the prize, two forms of identification, one of which must be a photo ID, will be required. Raffle stubs do not need to be kept for any reason; however all purchased tickets will be kept by Turnstone.
16. Turnstone reserves the right to cancel, modify or terminate the raffle prior to the raffle drawing if factors (for any reason) beyond its reasonable control occur with liability being limited to refund of ticket price to entrants.
17. The winner grants Turnstone permission to use his/her name, city, state, photograph and statement for publicity purposed by Turnstone and agrees to sign a publicity release without any further compensation.
18. Turnstone directors, officers, employees and their immediate family member are not eligible to win.
19. Ticket sales will end at 12 noon on October 12, 2017.
